Single Will



Private = £150 + Vat (£180 total)

Union member = £135 + VAT for (£162 total)
(where instructions do not fall under scope of free will writing service)

Mirror Wills



Private = £250 + Vat (£300 total)

Union member = £225 + Vat for Union (£270 total)
(where instructions do not fall under scope of free will writing service)

Complex Wills



Private = £300 + Vat for single (total £360) or £400 + Vat for a pair (£480 total)

Union member = £270 + Vat (£324 total) for single or £360 + Vat for a pair (£432 total)

Notice of Severance £75.00 + VAT

If a complex wills trust is required, such as a vulnerable beneficiary trust, prices start at £500 + VAT for a single will, and £600 + VAT for a pair.

To Obtain Grant of Probate only

Estimate £500 - £600 + Vat (£600–£720)

+ £5 Fee to swear Oath

+ £2 for each Exhibit eg a will

+ Probate and Court fee of £155

+ 50p per sealed Office Copy (2 usually required)

+ £3.00 charge for Office Copy Entry from Land Registry if required

Estimated total £766 – £886

Post Grant work

Usually costs between 1% and 2% of the cost of the estate.

Estimate between £1,500 – £2,000 + Vat (£1,800 – £2,400)
